Dear Canyon County Resident:

The Canyon County 9-1-1 Communications Center would like to invite you to register your **Cellular, Voice Over Internet (VoIP) or Unlisted** telephone number so that we, or your local unit of government, may notify you of situations that may have an impact on you and your loved ones. Reverse 911 is a telephone notification system we use to notify the public of significant incidents or emergencies effecting local neighborhoods and specific geographic areas within the county.

Once registered, your telephone numbers will not be used for any other purpose. Your numbers will remain absolutely confidential. Messages delivered to your telephone number will always be brief, informative, and provide you with direction to ensure the safety of your family, home or business.

Please take a moment and fill out this registration form to provide us with the most up to date information regarding your home or business telephone numbers. Please include your cell phone or TTY/TDD, identify any unlisted numbers, and if you have multiple telephone numbers for the same location, please specify the primary telephone number to be registered in the system. This information will allow us to remove unnecessary duplicate entries from the *Reverse 911* system to ensure its efficiency and effectiveness.
