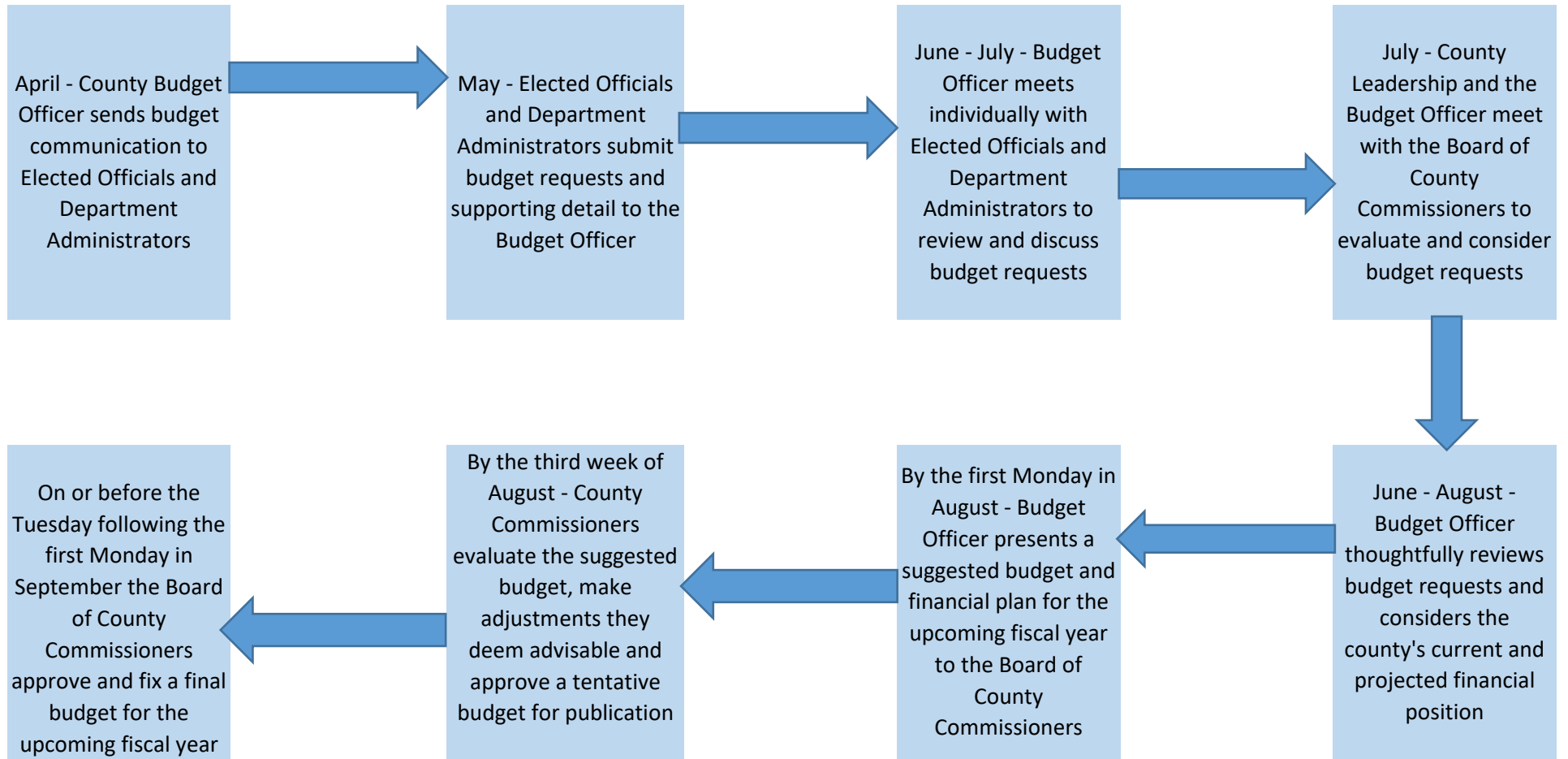

## Canyon County budget process and participants

-Preparing a county budget is a time and labor intensive process that requires the expertise and commitment of county Elected Officials and Department Administrators working cooperatively to develop a fiscally sound financial plan for the forthcoming fiscal year.

-Canyon County's fiscal year 2021 tentative budget is the result of dedicated efforts of county leadership and staff to complete and formalize a responsible financial plan including appropriate funding levels for need driven expenditures.

-Canyon County budget development follows the timeframe outlined below



# Canyon County Fiscal Year 2021 Property Tax Relief Budget

- Property tax relief is a focal point of the fiscal year 2021 budget
- Property taxes provide funding for mandatory and essential county functions
  - Public Safety
    - Jail & patrol operations, juvenile detention and probation
    - Criminal prosecution and Coroner services



- General Government
  - Court functions, property assessment, facilities maintenance
  - Administrative, information technology, elections
  - Treasury, human resources, communication and fleet

## Property Tax

- Health, Welfare, and Indigency
  - Public defense, indigent medical care & assistance and Southwest District Health
- Culture and Recreation
  - County fair, county extension office, parks, cultural and natural resources
- Public Works
  - Animal shelter and noxious weed control





# Statutory County Property Tax Responsibilities

- Canyon County performs the following core property tax functions
  - Property assessment and valuation
  - Equalization of assessments - Board of Equalization
  - Review and verification of property tax requests
  - Calculation and fixing of property tax levy rates
  - Billing and collection of property taxes
  - Remittance of property tax monies to local taxing entities

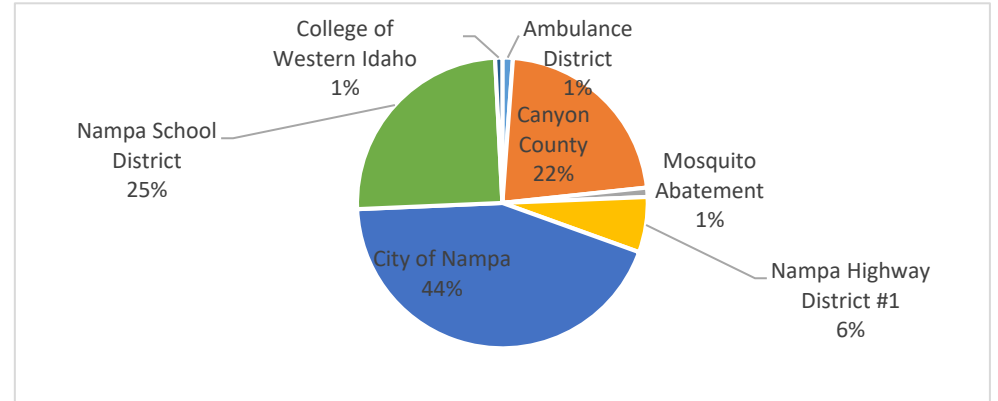


## There are 67 separate and unique property tax entities in Canyon County

- Sample property tax allocations below based on \$150,000 of taxable value in tax year 2019

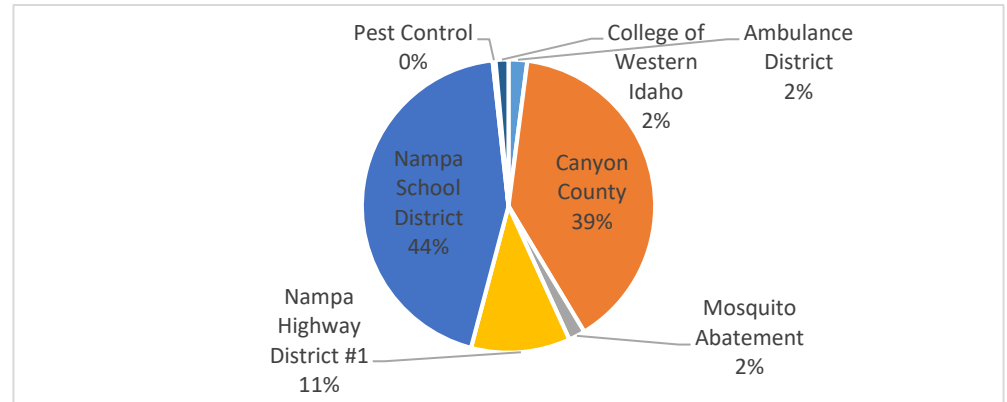

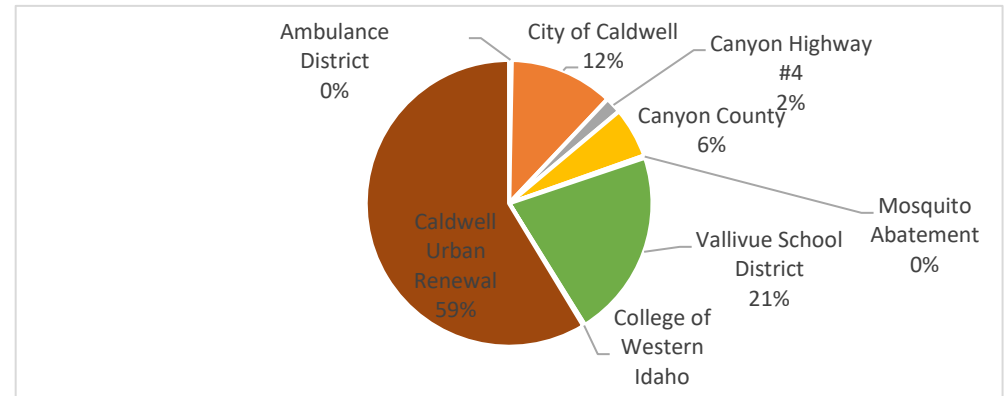

# Property not expressly exempted is subject to appraisal, assessment and property taxation

-Canyon County's estimated fiscal year 2021 net taxable value of property is \$17,022,133,918

-This amount equals a 12% or \$1,798,079,654 increase from the prior fiscal year

-In 2016 legislation was passed that capped the homeowners exemption amount at \$100,000

-In Canyon County in 2017, 13,801 properties were capped at the \$100,000 amount

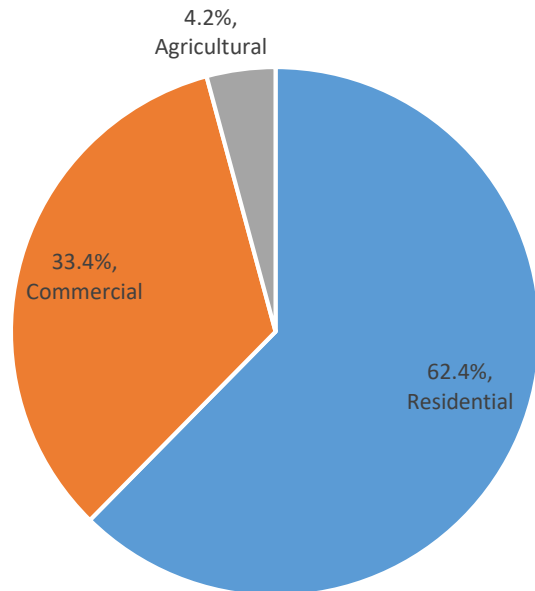
-In 2020 that number has nearly tripled to 38,629 properties now at the homeowners exemption maximum

-As a result the percentage of property taxes paid by residential properties from 2017 to 2020 has increased from 62% to 70%

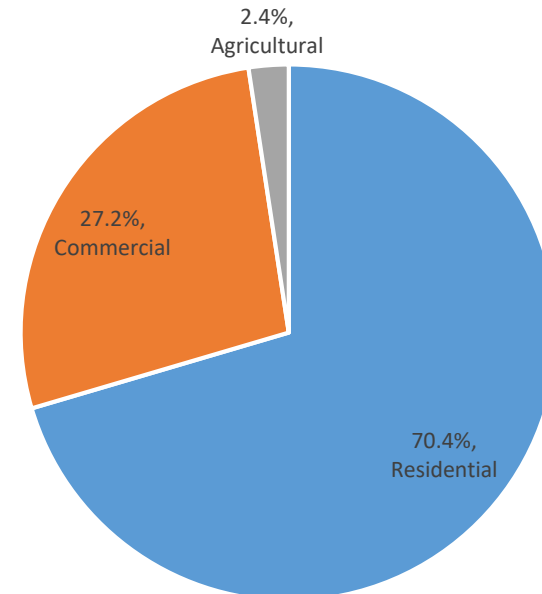
Tax Year 2017 Distribution of Value

## Annual Property Tax Levy

- Canyon County levied \$54,119,386 in property tax to support the fiscal year 2020 budget
- Property tax law allows the following additions or increases to the levied amount
  - 3% increase of \$1,644,629
  - New construction increase of \$2,104,781
  - Previously forgone increases of \$5,988,720



- Canyon County's fiscal year 2021 tentative property tax request includes:
  - \$0 additional dollars levied for new construction
  - \$0 additional dollars levied for the 3% increase
  - \$0 additional dollars levied for previously forgone increases
- Canyon County's fiscal year 2021 tentative property tax request is \$53,970,567



## Canyon County's fiscal year 2021 commitment to property taxpayers

- Property tax freeze from fiscal year 2020
- No additional property tax dollars levied from new construction or 3% increase
- Utilizing new growth to lower the property tax levy rate
- Projected fiscal year 2021 levy rate .003170611

## Canyon County's fiscal year 2021 tentative salaries and benefits expenditure budget

- Well trained, knowledgeable, qualified and skilled personnel ensure county services are capably delivered in a professional and timely manner.
- Canyon County's fiscal year 2021 tentative salaries and benefits budget amount is \$68,240,821.

The fiscal year 2021 tentative budget includes a responsible and sensible investment in our valuable personnel.

- Budgetary savings from unfunded positions in areas of decreased activity including indigent medical care & assistance and juvenile detention
- Continued implementation of the county compensation plan with step advancements for eligible personnel
- Additional positions in critical areas of need including driver's license, jail security services and solid waste operations
  - 2 driver's license customer service positions with a total budgeted amount for salary and benefits of \$96,000
  - 6 deputy sheriff positions in jail operations and courts & transport with a total budgeted amount of \$384,000
  - 1 fee collector position for solid waste operations with a total budgeted amount of \$48,000
- Overall reduction of \$170,204 in the county's fiscal year 2021 personnel budget from fiscal year 2020





## Canyon County's fiscal year 2021 tentative other operating expenditures & capital budget

A fiscally sound and responsible budget considers current needs and looks forward to ensure that future plans and obligations will have sufficient financial resources available to enable continued success in service delivery.

The budget process demands difficult decisions that must balance the needs of multiple stakeholders including our citizens and property taxpayers whose financial support is critical in the realization of county goals and objectives.

- Canyon County's fiscal year 2021 tentative other operating expenditures & capital budget is \$35,514,617
- \$9,286,938 is budgeted for investment in capital items including the following highlights
  - \$989,500 for a compactor to assist with solid waste operations
  - \$1,600,000 including previously accrued fund balance for a county fair expo building
  - \$2,300,000 in funding from the Caldwell Urban Renewal Agency for site improvement investments at the county fair
  - \$1,000,000 in emergency communications funding for a radio tower project providing enhanced communication capabilities
  - \$444,125 in grant funding for the Celebration Park recreational vehicle improvement project
  - \$769,000 budgeted for public safety and other county vehicles
  - \$1,000,000 budgeted for investment in general county capital needs

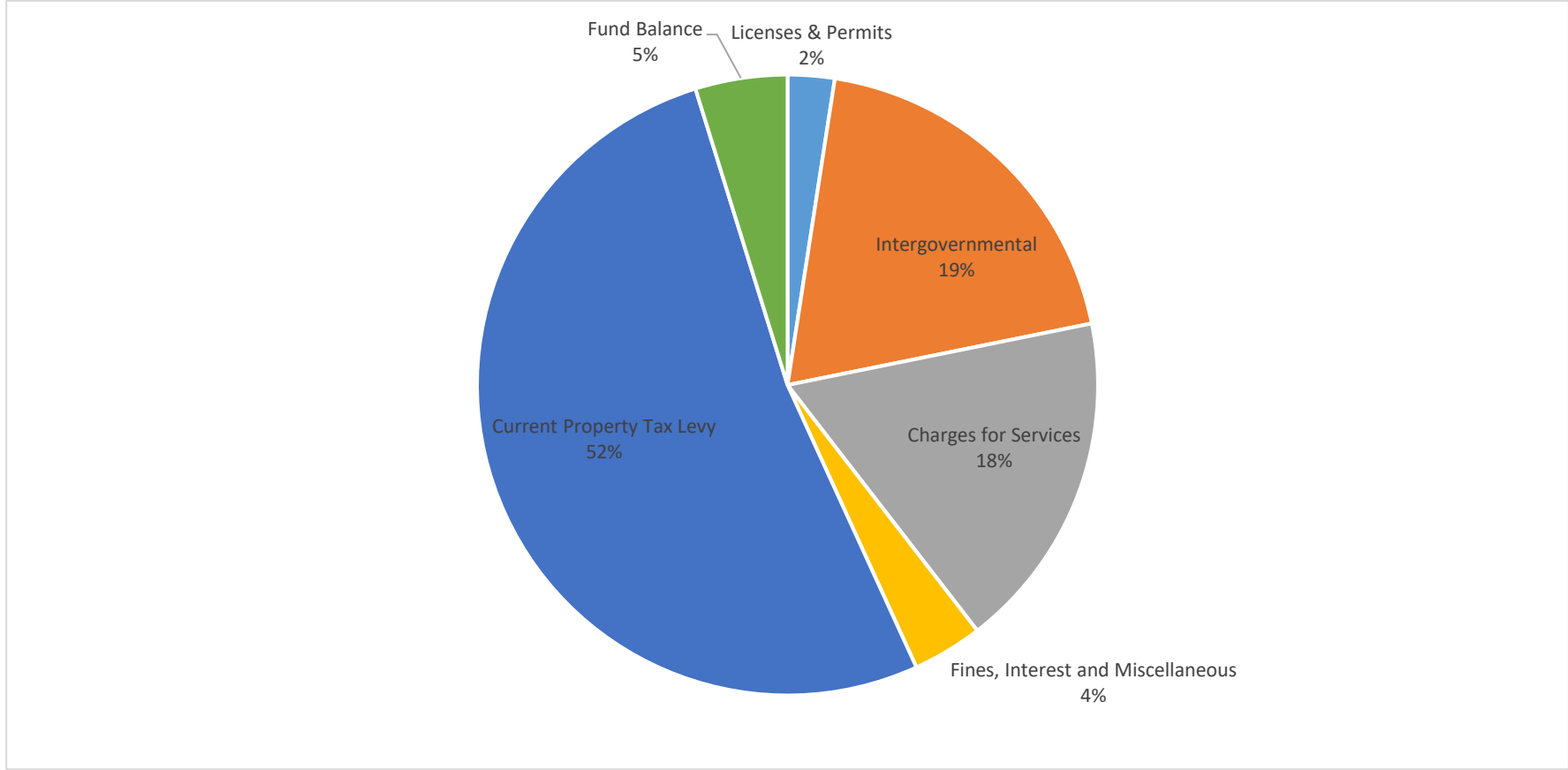




# Canyon County fiscal year 2021 tentative budget - funding by sources

- Canyon County works to expand revenue sources outside of property tax
- Grants, fund balance and revenues other than property tax are maximized to limit reliance on property tax
- Broad and diverse sources of revenue are utilized to protect property taxpayers and promote the county's financial security
